# General Data Protection Regulations 2018

### Company Statement

At Voyce Pullin, we are committed to data privacy and protection of personal data. GDPR compliance for us has required the development of our current information security management, improving and maintaining key data protection and privacy controls, and auditing the information that we hold. In order to ensure our continued and improved compliance with GDPR we will follow these principles:

## Privacy Statement

Cookies are text files placed on your computer to collect standard internet log information and visitor behaviour information.
